#### **\*** ENTRANCE TEST

- a) Entrance Test will be of 100 marks. There will be 100 MCQS for 1 mark each.
- b) Evaluation is based on negative marking rule. Accordingly, for every wrong answer ¼ of the marks allotted to that question will be deducted.
- c) The Entrance Test will be supervised by the teachers in the computer lab (Proctored).
- d) Re-examination will not be conducted under any circumstance.

#### Mock Test:

- a) Mock Test is conducted to check technical feasibility of the devices and Internet connectivity.
- b) Single Mock Test will be conducted on 12<sup>th</sup> July 2023 for LL.M-I.
- c) The Mock test will be supervised by the teachers in the computer lab (Proctored).

# GUIDELINES AND RULE AND REGULATIONS

## I. FINAL ENTRANCE TEST

- a) Students should kindly note that Mock test questions have no relevance with entrance test questions.
- b) Those candidates, who do not appear for 'Mock Test' and faces issue with credentials on the day of the main entrance test, cannot expect the college authorities to resolve the problem on the day of entrance test.
- c) Each candidate will receive login credentials and link (given below) for the exam portal called **Test Prep** on their registered Mobile Number/ E-Mail . These credentials should be used to login to the Test Prep link to appear for Mock and Final Entrance Test.
- d) In case of technical glitch candidate can log out and log in again. The data of solved questions will remain saved. In case of further problem, candidate should immediately contact the respective department before the time of the exam is over. (020 67656405)
- e) If the candidate could not click on submit button to end the test. The test automatically gets submitted at the end of 1 hour 45 min. So do not worry.
- f) No one other than the student should be present, while appearing for the entrance test.
- g) No breaks are allowed during the test. Session may get terminated on the grounds of idle time Students must agree for recording the test session for monitoring purpose.
- h) Students must agree to the Candidate Rules which appearing at the start of the test. Not agreeing to the above-mentioned precautions, may result in the cancellation of the test till further investigation.
- i) Verification of candidates is carried out with reference to a photograph submitted with application form.
- j) Evaluation is based on negative marking rule. Accordingly, for every wrong answer ¼ of the marks allotted to that question will be deducted.
- k) As it is proctored exam and your camera in ON candidate should ensure that they are properly dressed and seated in front of camera in such a way that your face is properly visible. (If student face is not properly visible college will terminate the test from their end) Proxy not allowed.

## II. DEVICE AND SETTING

- a) Giving examination on Laptop or Desktop is highly recommended, Instead of Smart Phone.
- b) Students are recommended to use web browser such as Mozilla, Chrome from your desktop/laptop/tab/smartphone. Do not use Safari browser.
- c) Entrance Test will be conducted in 'Proctored Environment'
- d) Candidate must attempt the test from a device that has a functional camera.
- e) The camera must be turned ON during the entire duration of the exam for both mock and final entrance test. (If the camera is found OFF college will terminate the candidate test from their end)

## III. INTERNET CONNECTIVITY

- a) It is the sole responsibility of the candidate to ensure good connectivity and bandwidth throughout the examination period.
- b) Must have an active, stable, and high-speed internet connectivity.
- c) Students should have sufficient data in Fair Usage Policy (FUP)/Internet plan with sufficient data pack of the internet service provider.
- d) If using a mobile phone, it should be in minimum 3G (4G desirable) coverage with at least 500 MB balance data.

#### IV. UNFAIR MEANS

- a) The candidate will receive a warning on his/her screen to unblock the view within a stipulated time. If the candidate fails to do so, then the college authorities will not allow the candidate to continue, and the test will be terminated.
- b) The candidate receives a warning and if he/she continues to switch windows further, the test gets submitted automatically due to malpractice.
- c) The following are treated as a malpractice:
  - i) Laptop/Desktop minimizing the test portal browser, switching to another tab on the browser, opening a new browser page, opening any document, notifications, pop-ups.
  - ii) Mobile device incoming call, messages, any notifications, pop-ups. Please apply Do Not Disturb service for smooth conduct of examination.

- d) The video feed from the camera will be used to verify the candidature along with previously submitted documents in application form. The college holds the right to disqualify a candidate if he/she is found to participate in malpractice after such scrutiny and verification.
- e) If a candidate is found with device like earphone or blue tooth, the test will be terminated by college.
- \* Re-examination will not be conducted under any circumstance.
